Process and Qualification for Membership

Qualifications:

A member/designee is a person who has reached the age of 25 years and shall (1) have a baccalaureate or higher degree from an accredited college or university; and have not less than four years experience in applied practice or, (2) have not less than eight years experience of responsible character in their professional field of expertise. By means of the membership application process shall demonstrate to the Board of Directors that the Member will by personal conduct within and outside the corporation support its purposes, promote its aims, and abide by its bylaws and house rules.

Sponsorship:

Candidates for membership must be sponsored by a member of the Club or its management staff. If the applicant is not acquainted with a member, the Director of Member Services will arrange a telephone interview or personal meeting.

Process:

Candidate shall submit the completed Membership Proposal Application to the Director of Member Services along with payment of appropriate initiation and pro-rated dues. The Candidate will immediately be granted Provisional Membership status allowing for activity at the Club with cash/credit payment until candidacy has been reviewed and approved by both the Membership Committee and Board of Directors at the end of each month.

Upon acceptance, a house charge account will be activated in the member's name and a membership card will be provided.
